ANNEXURE A

Particulars of claim:

- 1. The plaintiff and the defendant are the parties who are cited on the face of this summons to which these particulars of claim are attached;
- 2. A written agreement was concluded between the plaintiff and the defendant. A credit was issue to the defendant subject to the plaintiff's terms and condition on the 20 January 2005;
- 3. The Plaintiff duly performed in terms of this agreement and issued the defendant with a credit card;
- 4. The defendant used this credit card and as a result of such use became indebted to the plaintiff to the amount of R30 000 including interest at an amount of 18% from 20 January 2005 to date of final payment which amount is due and payable which amount, notwithstanding demand, the defendant has failed, alternatively refused alternatively neglected to pay;
- 5. The plaintiff has rights to approach the court as stipulated in section 130 of the National Credit Act 34 of 2005 in that:
 - 5.1 The plaintiff issued and delivered a notice to the defendant in terms of section 129 of the Act
 - 5.2 The defendant failed, alternatively refused alternatively neglected to respond to the aforementioned notice;
 - 5.3 The time periods stipulated in section 130 of the Act has lapsed

Wherefore the plaintiff prays for judgment against the defendant for:

- 1. Payment of the sum of R30 000;
- 2. Interest thereon at the rate of 18% per annum, from 20 January 2005, to date of final payment, both dates inclusive;
- 3. Costs of law suite on the scale as between Attorney and client;
- 4. Further and/or alternate relief
